Greetings

Management of Gulf Live Stock (PJSC) take this opportunity to present you company's first quarter financial statements (reviewed by auditors) for the period ended 31th, March 2014.

Main activities:

For the financial period ended 31th, March 2014, the company mainly focused its activities in investments and real estate leasing.

Financial performance:

The company earned revenue of AED: 7.3 million as compared to AED: 3.7 million in similar period of 2013. The company also achieved comprehensive consolidated net profit of AED: 5 million in first quarter as compared to consolidated net profit of AED: 2.2 million in same period of 2013. The earning per share (EPS) reached to 5 Fils per share compared to 2 Fils for the similar period in 2013. Company's total shareholders' equity reached to AED: 284.2 million from AED: 257.7 million as of March 2013.

Operational achievements:

Management is committed to continuously improve performance through effective management of leased properties and other investments. Due to these efforts, occupancy rate has increased to 95% same rate in both comparable periods.
